Joe McFadden to Lead Artist's Dialogue February General Meeting

Pack up a painting, finished or not, to bring with you to the Sunday, February 20th General Meeting of the Tallahassee Watercolor Society. Joe McFadden is back to lead us in an Artist's Dialogue. Joe has done this for the past three years. It has proven to be our most popular educational meeting.

For those who have never experienced this kind of artist's dialogue be ready to learn a lot about painting and composition. This is always a positive conversation for those who participate and observe. By all means, take notes.

The artist dialogue is a process of looking through and thinking about a painting. It is meant to emphasize the painting's strong parts and find solutions to the weak parts. There are 5 parts to this process:

1. Description: List everything seen in terms of objects, art elements, medium and subject.
2. Analysis: Formally evaluate the elements of art, principles of design and composition of the piece along with the artist's style.
3. Interpretation: What did the artist mean? What does the piece mean to you, the viewer. What influenced the artist?
4. Evaluation: Consider all of the above as well as originality, craftsmanship, presentation and power of communication.
5. Judgement: Is there a change between first impressions weighted against informed impressions?

An artist grows in the company of other artists. Share thoughts. Share experiences. This educational forum works wonderfully on unfinished paintings where problems develop that frustrate the artist. Bring a painting, finished or not, to discuss. Trust your fellow artists to give your answers.

It's our big show time of the year. We are pleased to hold the show at the Museum of Fine Arts at Florida State University, Tallahassee, FL. The show opens May 6th and runs through June 3rd.

The application deadline is Friday, March 4, 2011. The quality of artwork in past shows proves that we are a society of artists to be taken seriously. This year Michael Ireland, NWS, will be our Juror. His portfolio can be seen at www.irelandwatercolors.com.

"My love for watercolor has remained unabated for over 35 years. It's a very special medium. To paint in watercolor is to constantly learn...about the process...about yourself. As we know, anyone who works in this medium must spend years developing technique but it is the truly special artist that can combine that with the passion that comes from painting itself, no matter the medium. More than anything, I believe that is what I look for in a painting. To say that a painting needs to speak to you is certainly an overused term, but it doesn't make it any less true. I'm truly excited to be a part of this year's competition as a juror. My expectations are to walk away from this experience both inspired and humbled."

Michael Ireland has participated in the creative process for over thirty-five years beginning with his studies at the American Academy of Art in Chicago. Under the direction of master instructor Irving Shapiro, he began to explore the effects of light and color through transparent watercolor. He soon developed a passion for the medium that continued throughout his life and career. Today Michael is a nationally recognized painter as well as an accomplished creative director and graphic designer. Michael's painting style and technique challenges the scale and format associated with traditional transparent watercolor resulting in some of his recent works measuring up to over twenty feet in length. This process and approach has led to his artwork being placed in healthcare, corporate and residential collections throughout the country.

He was also the founder and creative leader of an award winning design firm specializing in film/video, graphic design and multi-media. His clients included Gatorade, Accenture, Baxter Healthcare, KPMG, Quaker Oats and Zenith to name a few. Leaving the world of commercial art in 2001, he made the commitment to turn his lifelong passion into his lifelong career. Michael is now focused solely on his career as a fine artist.

By-Law Changes

The TaWS board is recommending a few changes in the wording of to our existing By-Laws:

Article III: MEMBERSHIP AND DUES. Section 2; second sentence which presently reads “membership dues are payable January 1 and must be paid by March 1.....Change to “membership dues are payable January 1 and must be paid by March 31.” This change allows more time to pay dues pertinent to our Tri-State prospectus requirements.

“16th Century Paintings in the Now,” will bridge the gap between 400 years of Art

This Tallahassee Watercolor Society Exhibit will be in place by February 18 and can be viewed on the first floor of the Mary Brogan Museum Monday - Friday. The Tallahassee Watercolor Society is pleased to collaborate with the Mary Brogan Museum of Art and Science in this vital cultural exchange that will give our region a view of art history as it was in the 16th Century.

“This opportunity has been a great experience for our artists,” commented TaWS President Mary Apple. “The Watercolor Society’s exhibit will show the contrast on how today’s artisans move in their art forms as they depict their “take” of the exhibited works from Italy.

Twenty-eight TaWS artists have created their view of the 16th Century Baroque paintings from the Italian Pinacoteca di Brera Museum that will be shown in the first floor gallery space of the Mary Brogan Museum. The exhibit will feature works of the following TaWS members:

Exhibition Opportunity

Donna Cirenza, Operation Manager, of the LeRoy Collins Leon County Public Library has contacted Mary Apple, TaWS President, after seeing Brush Strokes at the Brogan about the possibility of using the library as an exhibition venue.

This is an opportunity for one or two artists at a time to hang their work on the second floor of the main library for a month. The artist will be responsible for providing painting titles and contact information next to the painting, so a prospective buyer can contact the artist directly. Leon County will not charge a commission should your art be sold. While the TaWS board cannot endorse the library as a society sponsored venue, as the library has no liability policy on the paintings, there will be, however, a Deputy Sheriff on the premises when the library is open.

The display area has a tackable surface 30 x 5 feet equipped with the Walker Hanging system featuring hanging brackets for framed artwork and rods for hanging quilts or cloth banners. It also has 2 locked display cases 56 1/2" x 26 1/2" x 9."

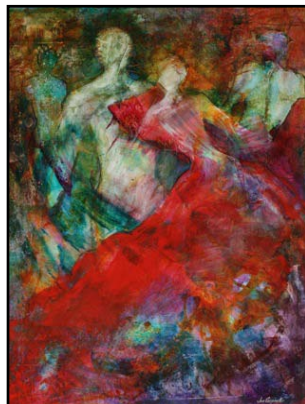
